

This deed of Memorandum of Understanding (MOU) is entered on this 1<sup>st</sup> day of November, Two Thousand and Twenty Two at Tiruchirappalli between the following two parties.

campus at Dindigul Road, Karumandapam, Tiruchirapalli and represented by its Principal **Dr. K. Kumar**, hereinafter called as 1<sup>ST</sup> PARTY.

#### AND

Global Nature Foundation henceforth named as GNF, is a Non-Governmental Organization. It was established in the year 2011 and the first State First, National level award, and many other awards on various grounds related to Nature and Biodiversity conservation. Several articles have been published in many magazines about the activities of the trust. They offer training periodically to farmers, schools, college students and to the public besides. Environmental conservation, Wildlife conservation, and integrated organic farming are some of the areas under focus. Recently, the GNF has extended their services to the mentally challenged, by offering residence in their 'Home' specially constructed for the purpose. GNF is represented by Founder – Mr. Naveen Krishnan hereinafter referred as "2nd PARTY"

### 1. Purpose of the Memorandum of Understanding (MoU) is:

- To establish a beneficial relationship between "The Department of Biotechnology & Microbiology, National College (Autonomous), Tiruchirapalli" and "Global Nature Foundation", Thuraiyur, Tamilnadu, in the field of student Internships, Training, Extension activities and Environmental Outreach Programs".
- To promote co-operation and expansion of academic and field-based learning among the students.

#### 2. General Terms of MoU

**Duration:** This MoU shall be operational upon signing and will remain active for a period of **Three** years from the date of signing.

Coordination: Activities of mutual interests will be coordinated through an appropriate person(s) representing the institutes.

**Financial implications:** There is no financial commitment between the parties in this MoU and if any arise, shall be decided case to case basis.

Confidentiality: Each party agrees that it shall not, at any time, after executing the activities of this MoU, disclose any information in relation to these activities.

**Termination of MoU: B.** This memorandum of agreement, the respective institutions' commitment to both research and academic exchanges as on the date of the memorandum of understanding. This memorandum of agreement may be amended or terminated at any time by either party provided that notice of termination or amendment in writing provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to become effective.

Equality: Both institutions subscribe to the policy of equal opportunity and will not discriminate on the basis of gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin or sexual orientation. The IPR issues involved will be decided on a case by case basis.

Communications: All notice, demands and other communications under this agreement in connection herewith shall be sent to the last known address or e-mail, of the concerned party. Any notice shall be effective from the date on which reaches the other party.

**Addendum:** Any addendum to this MoU shall be in writing and signed by both parties. Both parties assume that this agreement does not go against the rules and regulations of the Government policies.

The terms and provisions in this MoU may also apply to any subsequent addendum to this agreement.
