MINDZCUBE SOFTWARE DEVELOPMENT & CONSULTANCY, Mannargudi-614001 & Bangalore-560053 (The Second Party) represented herein by its Consultant, Mr. Y. Shahul Hameed, Email: shahul@mindcube.com and info@mindcube.com.

WHEREAS

A) The First Party is a Higher Educational Institution named: NATIONAL COLLEGE (AUTONOMOUS), Trichy-620001.

B) Mindcube Software Development & Consultancy, Mannargudi-614001 & Bangalore-560053, The Second Party is engaged in Software development and consultancy.

C) The First Party & the Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

D) The Parties intend to cooperate and focus their efforts on cooperation within the areas of Skill Based Training and Placement assistance.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

1.1 Both the Parties are united by common interests and objectives, and they shall establish cooperation

1.2 The First Party and the Second Party co-operation will facilitate effective utilization of the intellectual capabilities.

1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, sign relevant agreements.

CLAUSE 2: SCOPE OF THE MOU

2.1 **Skill Based Training:** The Second Party will actively execute the skill-based training programmes on:

2.1.1 **NCT - Student Transformation Programme** covering skills-based training modules on data intelligence, designing (UI/UX, Graphics & Motion, Typography, etc.), digital social web media analysis, artificial intelligence and digital transformation

2.1.2 **Computer Applications (BCA) Student Internship Placement Programme** covering skills-based training modules on **In-Demand Web Development** (HTML, CSS, JavaScript, React, Node with related-industry tools) and **Digital Social Media Development** (SEO&SEM, DS Media Marketing, DS Media Development, Content Writing, Content Management with related-industry-tools).

2.2 **Placement of trained students:** The Second Party will actively engage to help the delivery of the training and placement assistance of the students of the First Party based on the skill-based trainings conducted by the Second Party.

2.3 There is no financial commitment on the part of NATIONAL COLLEGE (AUTONOMOUS), Trichy-620001, and the First Party to take up any Programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

2.4 Both the Parties will obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3: VALIDITY


3.1 This Agreement will be valid for a period of life time and can be terminated by either Party on three months written notice without affecting ongoing commitments.

CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES


4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.


