



- 2) The spirit of this MoU is to synergize and exchange various resources available with the Sri Vasavi College, Erode and National College (Autonomous), Tiruchirappalli, such as sharing technical knowledge, research laboratory facilities, literature in the form of books, periodicals, journals, teaching and training aids.

- 3) Both Parties agree to encourage the following exchange activities based on their respective academic and educational needs.
- Exchange of Scholars
 - Exchange of Research facilities
 - Joint Research Programs
 - Joint Conferences
 - Joint Online Programs
 - Other Academic exchange Programme as may be agreed to by both the parties from time to time
- 4) The implementation of each exchange program referred above will follow the guidelines established on mutual agreement by both the parties. Efforts will be made by both parties to find financial resources for carrying out the activities listed above.
- 5) Nothing shall diminish the full autonomy of either institution nor will any constraints be imposed by either upon the other in carrying out the agreement.
- 6) This agreement shall be in force for a period of THREE YEARS from the date of the last signing and is subject to revision or modification by mutual agreement. It is also understood that this agreement may serve as the basis for the specific agreements to be developed at a later date. It is further understood that either institution may terminate the agreement at any time, upon one year written notification to the partner institution, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.
